- 1. Meeting called to order by Sally at 7:34 pm
- 2. Attendance Nancey, Dar, Patrick, Mike, Sally, Jim, Sarah
- 3. Presidents report (Sally) Justin has stepped away from the board effective immediately. Mike will take notes for tonight, and is also willing to do that until we find a replacement
 - a. Soccer update with MTC already having tried offering free drop-in soccer in the community and then stepping away, we will not be going forward with this. There is also another organization (Go Play) that is offering it in the community.
 - b. Soccer (MTC) Dar and Nancey said that they will pass along the MTC opportunity (fields that have been paid for but will not be used) to other groups who might be interested in participating.
